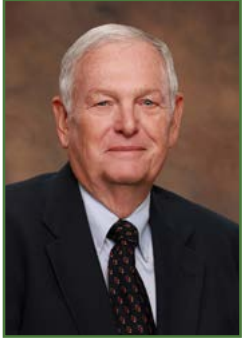
**Mrs. Pamela Robertson**

Nominations for vacancies may also be made by petition signed by 1% of the membership with a minimum of 25 and a maximum of 500. Each nominee by petition must submit a similar statement of qualifications and biographical data with the petition. To be effective, nominations by petition must be accompanied by a signed certificate from the nominee or nominees stating that they are agreeable to nomination and will serve if elected to office. Nominations by petition must be filed with the secretary of the credit union by March 8th, 2024. Please contact Fort McClellan Credit Union at 256-237-2113 regarding nominations by petition. Elections will not be conducted by ballot and there will be no nominations from the floor when there is only one nominee for each position to be filled.
